Scripts: Please send one copy of an original script (booklet from a publisher) to Mike Doggett for the purpose of sending it to the Critic Judge. **Please mail it by March 1, 2010.** Also remember you will need another cut original script at contest for the music timer, bring this script with you to the site rehearsal or mail it along with the judges script on or before March 1, 2010. **A reminder that a UIL rule requires the director to present a script to the contest manager before the rehearsal is started along with proof of royalty payment, etc. This script shall represent exactly what is being performed. The script must be an original from the publisher (no copies made by a copy machine are allowed due to copyright) unless it is public domain.**

Sound: Your crew must operate any sound your show requires. Schools may bring their own sound equipment or use the house sound system. Detailed questions should be directed to the site host, all information will be posted on the contest website.
